### 3 HAZARDS IDENTIFICATION

Most importantHighly flammable. Irritating to eyes. Repeated exposure may cause skin dryness or cracking.hazard:Harmful by inhalation.

### 4 FIRST AID MEASURES

Inhalation: Provide fresh air and rest.

Skin contact: Wipe off. Wash off with soap and water. *Never* wash skin with organic solvents.

Eyes: Wash with plenty of water. Obtain medical attention.

Consumption: Do not induce vomiting. When conscious, drink a lot of water. Obtain medical attention.

### 5 FIRE-FIGHTING MEASURES

Suitable fireextinguishing media: Powder, carbon dioxide (CO2), foam or fine water spray.

### 6 ACCIDENTAL RELEASE MEASURES

Personal precautions:	Consider the risk of fire. Remove all sources of ignition. When large emissions occur, consider the needs for personal protection equipment.
Environmental precautions:	Prevent the product from reaching drains, water or ground.
Methods for cleaning up:	Soak up with inert absorbent material (e.g. sand silica gel, acid binder, universal binder, sawdust). Keep in suitable, closed containers for disposal.

### 7 HANDLING AND STORAGE

Safe handling:	Avoid contact with skin, eyes and clothes. Store well ventilated areas. Mechanical ventilation or exhaust device may be required. Avoid smoking, fire, sparks or other sources of ignition. Implement measures to avoid static electricity. Observe applicable rules for handling organic solvents.
Storage:	To be stored at temperatures between 0 and 30°C in ventilated areas away from sources of ignition. In case of storage of large quantities, consult the local fire brigade.
Packaging:	Store in sealed, original packaging or in other sealed metal or glass packaging.

# EXPOSURE CONTROLS/PERSONAL PROTECTION

Respiratory protection:	Depending on the quantities handled and on working conditions, respiratory protection type A2 or fresh-air mask may be required.
Protective gloves:	Solvent-resistant gloves (butyl rubber).
Eye protection:	Safety goggles are recommended.
Technical measure:	Use sparkless tools.
Hygiene:	The product should be handled in accordance with good occupational hygiene and safety practice. Avoid contact with skin, eyes and clothing.

## 11 TOXICOLOGICAL INFORMATION

Acute toxicity:	Inhalation of vapour from the solvents may cause headache, tiredness, dizziness, nausea, longer reaction times and unconsciousness (with large quantities).
Local effects:	Degreases the skin and may cause cracks/skin irritation, irritates eyes. Consumption may give gastrointestinal irritation, nausea, vomiting and diarrhoea.
Chronic toxicity:	Prolonged inhalation of high concentrations may give chronic damage. Repeated or prolonged skin contact may cause exzema.
